The Simpson County Board of Education met in regular session on Thursday, April 15, 2010, with all members present. The following business was transacted.

- 1. Mr. Flynn made welcome announcements including: upcoming KCCT testing schedule, Science Olympiad Winners, National Child Abuse Prevention month, two students (David Sekora and Joseph Tutor) selected for Gatton Academy, 1st grader Daniel Phelps –winner of KHEAA "Dream Out Loud Challenge", FSHS Welding Fabrication team won 1st place in state SKILLS competition, opening of the FFA Greenhouse and the 2010 Cheerleading banquet/awards-held at the *Roxy*.
- 2. Chairperson David Webster called the meeting to order and the agenda was approved.
- 3. Adam Hatcher introduced examples of learning from students at LOPC, which included a Power Point on the interdisciplinary gardening project by Shelby Edwards, a presentation by Cody Shedd on "How far do you travel each day?" and personal poetry shared by Chris James.
