The Simpson County Board of Education met in regular session on Thursday, July 21, 2011, with all members present. The following business was transacted.

1. Mr. Flynn made welcome announcements including our new Academic Program Consultant, Whitney Maxwell. First day of school for students is August 10th. Opening day for staff is August 5th. Registration for K-12 will be held at the FSHS on July 26th and 27th. Open House schedules are on the school website's district calendar. A "Back to School Jeans Jam" will be held on Saturday, July 30th at Franklin Elementary. The Kiwanis Club is collecting items for schools, at various locations in Franklin. Fashion Bug has partnered with the Transportation Dept. for a "Fill the Bus" event to be held each Saturday in July. FSHS on ihigh.com was named a national Top 100 school site. FFA first place winners at State competition were: Kali Duncan, Taylor Pinson, Molly Fleming and Olivia Eaton. These students advance to national competition this October.
