The Simpson County Board of Education met in regular session on Thursday, March 19, 2009, with all members present. The following business was transacted.

1. The agenda was approved.
2. A musical presentation was given by FES students, under the direction of Elizabeth Little. A slide presentation (created by FSHS Senior Will Wade) was shown by Stacy Raymer, Principal of FES.
3. Mr. James Flynn, Superintendent congratulated our students on many accomplishments, including awards for our FSHS Basketball teams, competition winners in FCCLA, JAC/DAR, Catflash Staffers, SKILLS USA, HOSA, FFA, FBLA, Simpson-Lincoln Academic Team, FSMS/FSHS Combined Choir, Simpson County Band and MLK Day Essay/Art Contests. Tony Pogue won the state indoor championships in the shot put. Ariel Wren won an opportunity to sing the National Anthem at a Hot Rods baseball game this July.
