The Simpson County Board of Education met in regular session on Thursday, March 18, 2010, with four members present. Brigette Crawford was unable to attend due to family illness. The following business was transacted.

- 1. Mr. Flynn made welcome announcements including two new Board members: Greg Coker and Nancy Bunton (who were sworn in Monday, March 15th), Census 2010 participation, numerous achievements by our students in Mathcounts, AAA contest, FBLA, LES Leadership, FFA, SES-LES Academic Team, FS Band, American History Contest and HOSA (details of winners are on the school website). In addition, Mr. Swack won Outstanding Governing Board member and 3 teachers were recognized by Campbellsville University for Excellence in Teaching (Mrs. Smith, Mr. Brown and Mrs. Watt).
- 2. Chairperson David Webster called the meeting to order and the agenda was approved.
- 3. Supt. Flynn recognized Mariah Rowland for her achievements at the Kentucky Junior Miss competition. Mariah spoke about the mission of Junior Miss. She also announced that an LES Young Miss event (for 5th graders) will be held Thursday, March 25th.
